4. My Obligations and Responsibilities as a HSRF Scholar:

- 4.1. I agree that, as an HSRF Scholar, I will continue to demonstrate and maintain the highest of moral character in my daily conduct and throughout the course of any continuing financial assistance from HSRF.
- 4.2. I understand that, before the Foundation will make any payment on my behalf, I must complete this form, Agreement and Contact Information, Form HSFR-105. It is my responsibility to keep this form up-to-date at all times until I am no longer an active HSRF Scholar.
- 4.3. I understand that, as a HSRF Scholar, I must maintain a minimum class load by completing and passing classes totaling at least 12 semester hours each semester in the chosen degree program. In addition, I agree that I must have accumulated sufficient semester hours credit after the end of each semester so as to demonstrate the ability to complete the specified degree program within the commitment period.
- 4.4. As an HSRF Scholar, I must maintain a minimum GPA of 2.5 in a 4.0 system both cumulative average and semester average for college classes after leaving high school.
- 4.5. I will not change major or degree plan without prior agreement in writing from the Foundation.
- 4.6. I will not change my financing plan without prior agreement in writing from the Foundation.
- 4.7. At the end of each semester and before the beginning of the next semester, I agree to complete HSRF-106 to report current semester classes, grades, account status, and plans and costs for next semester.

5. Probation

- 5.1. I understand that a HSRF Scholar may be placed on probation by the Foundation for any of the following:
 - any violation of HSRF requirements and conditions for continued financial aid except that a violation of the moral character condition will result in immediate termination;
 - 2) the school in which I am enrolled places me on probation for any reason;
 - 3) failure to provide information required of the HSRF Scholar by the Foundation;
 - 4) failure to meet the required number of semester hours credit or evidence that it cannot be obtained in one semester
 - 5) failure to meet the requirements for semester and cumulative GPA or evidence that the required GPA for a semester or cumulative cannot be attained in one semester;
 - 6) criminal proceedings against me.
- 5.2. While on probation, the Foundation may choose to provide all, part, or none of the committed

financial assistance until such time as I am able to bring my performance into compliance with the Foundation's requirements for continuing financial aid.

- 5.3. Should I not complete my return to compliance with HSRF requirements within one semester, I will remain on probation for one additional semester.
- 5.4. Being on probation does not extend the term of the commitment by HSRF to me.

6. Termination

- 6.1. The commitment of HSRF to me is terminated by any of the following:
 - 1) any violation I make of the moral character conditions of financial aid from HSRF;
 - any attempt by me or my representative to deceive, hide, or obscure facts from the Board either during the application process or following the award even if discovered after the commitment was made by HSRF to me;
 - 3) my withdrawal from the school that I am enrolled in;
 - 4) the school I am enrolled in expels me for any reason;
 - 5) if, as an HDRF Scholar, the Foundation places me on probation for any 2 semesters, sequential or not, without my returning to compliance with all requirements of the HSRF for continuing financial aid;
 - 6) completion of the Foundation's period of time stated in HSRF commitment letter or four (4) years, whichever is less, and/or total amount of committed financial aid having been disbursed;
 - 7) I am convicted of a crime.

7. Terms and Conditions

- 7.1. The Foundation reserves the right to amend it requirements, documents, and policies at its sole discretion as it deems necessary.
- 7.2. The Foundation Board Members reserve the right to require more information as it may deem necessary.
- 7.3. Decisions of the Board Members are final.
- 7.4. The Foundation Board Members have the sole decision making authority over all Foundation requirements, policies and administration.
